


### With Flat Sugar Prices Since 1985: More Than Half of U.S. Sugar-Producing Operations Have Shut Down

2018/19-2020/21 Average - Thousand metric tons/year, raw value -



The 28 countries of the European Union, taken as a whole, produce 17.0 mmt of sugar on average.


## United States: World's Third Leading Sugar Net Importer 2018/19-2020/21 Average


### United States: World's Third Leading Sugar Consuming Country

-- Shares of Global Exports, 2018/19-20/21 Average --





# Sugar Cost as % of Retail Products Price\* - Sugar Share Mostly Insignificant -







-- Cents per pound, 2008-2018 average --





## 2018 Farm Bill: 11% Increase in Beet Sugar Loan Rate - Only Second Support-Price Increase Since 1985




1970 U.S. Per Capita Daily Caloric Consumption; Sugar & Sweeteners' Share 16%

#### 2014 U.S. Per Capita Caloric Consumption Up 19% (374 Calories)



At the time of this study, US, Canada, and Mexican domestic sugar prices were 28¢/lb, 21¢/lb, and 23¢/lb, respectively. That implies that for an average candy facility, savings on wages and benefits were more than 10x's larger than the savings on sugar when comparing a move from the U.S. to Canada; and more than 30x's larger when comparing a move from the U.S. to Mexico.
